

## The Voice S26 Win a Trip to Universal Orlando Resort Sweepstakes

Official Rules

November 26, 2024 – December 10, 2024

**PRELIMINARY INFORMATION:** NO PURCHASE NECESSARY. A purchase will not improve your chances of winning. Void where prohibited. The Voice S26 Win a Trip to Universal Orlando Resort Sweepstakes (“Sweepstakes”) will begin on November 26, 2024 at 12:01 A.M. PT and end on December 10, 2024 at 11:59 P.M. PT (“Sweepstakes Period”). All times in the Sweepstakes refer to Pacific Time (“PT”). Odds of winning depend upon the number of eligible Entries (as defined below) received. Sweepstakes is subject to all applicable federal, state and local laws. **PRIZE (AS DEFINED BELOW) DOES NOT INCLUDE ACCOMMODATIONS, PARKING OR TRANSPORTATION BEYOND THAT SPECIFIED BELOW.**

**ELIGIBILITY:** Open only to permanent, legal United States residents who are physically residing in one (1) of the fifty (50) United States or the District of Columbia (excluding Puerto Rico, Guam, the Virgin Islands and other United States territories), and who are eighteen (18) years of age or older and of the age of majority in their state of residence as of the start of the Sweepstakes Period. Officers, directors, and employees of Sweepstakes Entities (as defined below), members of these persons’ immediate families (spouses and/or parents, children, and siblings, and each of their respective spouses, regardless of where they reside), and/or persons living in the same households as these persons (whether or not related thereto) are not eligible to enter or win the Sweepstakes. **Limit one (1) Entry per person during the Sweepstakes Period.** Multiple Entries received from any person beyond this limit will void all such additional Entries. Entries generated by a script, macro, or other automated means or by any means that subverts the entry process will be disqualified. **Entries must be received before December 10, 2024 at 11:59 P.M. PT to be eligible for the Sweepstakes.** Sponsor’s computer shall be the official timekeeper for all matters related to this Sweepstakes. Entries that are incomplete, garbled, corrupted, fraudulent, or unintelligible for any reason, including, but not limited to, computer or network malfunction or congestion, are void and will not be accepted. In case of a dispute over the identity of an entrant, the authorized account holder of the email address used to enter will be deemed to be the entrant. “Authorized account holder” of an email address is defined as the person who is assigned to an

**PRIVACY:** Entrants may have the opportunity to receive information from Sponsor and selected partners by checking the appropriate box(es). If, at any time, you no longer wish to receive materials from Sponsor or our partners, please go to our privacy policy, located at <https://www.nbcuniversal.com/privacy>, or the applicable partner's privacy policy and follow the procedures indicated.

**WINNER SELECTION AND NOTIFICATION:** On or about December 11, 2024, one (1) potential winner ("Winner") will be selected in a random drawing by representatives of Sponsor from all eligible Entries received during the Sweepstakes Period. Sponsor will make two (2) attempts to notify potential Winner at the email address submitted at the time of Entry. **Sponsor may share potential Winner's name and contact information with Sweepstakes Entities and/or Prize Provider, as applicable, if necessary.** Potential Winner(s) may be required to execute and return an affidavit of eligibility, release of liability, and, except where prohibited, publicity release (collectively, "Sweepstakes Documents") within two (2) days of such notification. Prize will consist of one (1) trip ("Trip") for Winner and three (3) guests (collectively, "Guests", each a "Guest") to Universal Orlando Resort in Orlando, Florida. Trip will include the following: (a) roundtrip economy air transportation for Winner and Guests from a major airport located within the United States near Winner's place of residence (as determined by Prize Provider in its sole discretion) to a major airport located in Orlando, FL\*; (b) four (4) nights' standard hotel accommodations (one room, quadruple occupancy, room and tax only) for Winner and Guests at Universal Endless Summer Resort - Dockside Inn and Suites or at another Universal Orlando Resort hotel (as determined by Prize Provider in its sole discretion); (c) non-exclusive ground transportation for Winner and Guests in Orlando, FL between the airport and hotel\*; and (d) Universal Orlando 3-Park 3-Day Park-to-Park PLUS 1-Day Universal Epic Universe Tickets for admission to Universal Studios Florida and Universal Islands of Adventure theme parks, Universal Volcano Bay water theme park, plus one (1) day admission to Universal Epic Universe for Winner and up to three (3) Guests. \* For a winner who is a Florida resident, air transportation may be substituted with another method of transportation by Prize Provider in its sole discretion.

If Winner chooses to partake in any portion of the Prize with fewer than three (3), or no, Guests, the remaining elements of Prize shall constitute full satisfaction of Sponsor's Prize obligation to Winner and no additional compensation will be awarded. Each Guest, if any, may be required to execute and return releases of liability and, where legal, publicity releases (collectively, "Guest Documents"), which must be returned with the Sweepstakes Documents, or Guest portion of the

PROVIDED, HOWEVER, ANY DISPUTES, CLAIMS, AND CAUSES OF ACTION AGAINST UNIVERSAL ORLANDO RESORT ARISING OUT OF OR RELATING TO ANY PERSON'S USE OF, OR PARTICIPATION IN ANY PORTION OF THE PRIZE INVOLVING UNIVERSAL ORLANDO RESORT ("PRIZE CLAIMS") SHALL BE RESOLVED BY APPLYING THE LAWS OF FLORIDA, WITHOUT REGARD TO CONFLICT OF LAWS PROVISIONS THEREIN, AND SHALL BE SOLELY AND EXCLUSIVELY BROUGHT IN STATE OR FEDERAL COURTS WITHIN ORANGE COUNTY, FLORIDA AND SUCH CLAIMS SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION, AND ALL SUCH CLAIMS SHALL BE LIMITED TO ACTUAL OUT-OF-POCKET COSTS INCURRED, BUT IN NO EVENT TO INCLUDE ATTORNEYS' FEES AND ANY DISPUTES.**

THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN NEW YORK. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN THE COUNTY OF NEW YORK, NEW YORK. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL, OR INCIDENTAL DAMAGES, INCLUDING ATTORNEY'S FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.**
